The Annual Wilton Founders Day Celebration will be held Friday, August 27th and Saturday, August 28th.

Founders Day will be held on Maurer, Cedar, 4th & Railroad Sts. The length of the exhibit space along the curb may be selected in 10-foot increments after the first 15' increment. Be sure to reserve enough space to accommodate your booth or trailer and enough space to get your tow vehicle in to park the trailer. The depth of the space is approximately 12 feet from the curb toward the center of the street. Please keep your booth within the area you reserved to prevent over crowding. All electrical circuits are GFCI protected.

You may set up any time after **3:00 p.m.** on August 27th or on Saturday after 7:00 a.m.

PLEASE NOTE: Snap pops, stink bombs, string pops, silly string, knives or weapons of any kind will not be allowed. Vendors must be off the streets by 3:00 a.m. or they will be towed. Anyone found selling these items will be asked to leave immediately!!
